1. CAPTURE:

I was captured several hours after my regiment had surrendered on 12 Jun 40 at ST. VALERY EN CAUX.

2. CAMPS IN WHICH IMPRISONED:

Political prison (ROUEN) Stalag VIII B (LAMSDORF)

11 Sep - 1 Dec 41. Dec 41 - May 43.

3. ATTEMPTED ESCAPES:

(a) First attempted escape and evasion for 15 months.

12 Jun 40, Escaped from guards at ST. VALERY-EN-CAUX.

I was taken to an apple orchard in the town of ST. VALERY after I had been captured, where a German regiment was quartered. During the evening my guards began drinking and I seized the opportunity when they were not watching, of slipping off under cover of darkness and got away. I climbed over the hedge surrounding the orchard and walked up the road. On the way a German sentry called on me to halt, but I shouted out "Camarade" and he let me go by. /I hid ....

15 Jun 45. FECAMP.

I hid that night above a hen house and then continued on my way to ST. PIERRE EN PORT (N. W. EUROPE 1:250,000, Sheet 4, L 85). The next evening I met a Frenchwonan who gave me some food and directed me to FECAMP (L 65) which I reached on 15 Jun. Here I hid in a shed in the electricity works, where I found some civilian clothing which I put on, and left again the same evening, walking in the direction of LE HAVIE (L 42).

17 Jun 45, LE HAVRE.

I reached LE HAVRE on 17 Jun and hid in empty houses in the town for the Aext two days. During this time I collected a bicycle, a pistol and armition and some binoculars. Armed with these, I cycled to ST. GILLES DE CRETOT (L 83), where I had been stationed for a short while during the earlier part of the year, and where I had several French friends. Here I was given civilian clothing and told that it was imposible to cross the river SEDVE. I spent the night at the house of one of my friends' relatives and then moved to another house near the woods the next day.

21 Jun 40 -11 Sep 41. ST. GILLES DE CRETOT.

I remained in the district of ST. CILLES DE CRETOT from 21 Jun until 11 Sep 41. During this time I joined a small group of people who did a certain amount of sabotage in the district. I did not try to make my way to Spain, as I thought that the second front would be starting and I did not want to risk being picked up and interned in Unoccupied FRANCE. I trusted my French friends/implicitly and considered that it was wiser to remain where I was than to continue my journey.

While I was living in ST. GILLES DE CRETOT I met two British soldiers, Cpl. STAMPER and Ptc. WOODBURN, whom I believe were both from the Border Regiment. They stayed with me until May 41 when, at their request, I put them into contact with an organisation which was able to send them through to Unoccupied FRANCE. I warned them that they would have to make their own way to SPAIN once they had crossed the demarcation line and that there was considerable risk of being interned, but they insisted on going. I heard later that they had both been interned.

11 Sep 41, Recaptured and imprisoned at

On 11 Sep my presence was given away to the Gestapo by two women. The house in which I was staying was surrounded and I had no opportunity of getting away. I was taken to the political prison at ROUMN where I was interrogated on many occasions and kept there for 80 days. I was severely beaten up because I would not give the names of those with whom I had been in contact. I was also given very little food.

On 1 Dec 41 I was sent to Stalag VIII B (LAMSDORF) (GERMANY 1:100,000, Sheet 117, 6703) where I was put into a Straflager until 2 May 42.

## (b) Second Attempted Escape.

At the beginning of May I volunteered to go out in charge of a Working Party near TRAUTHNAU (Sheet 115, 6403). On 8 May I escaped at night with the intention of making for FRANCE. I took with me some bread and vitamin tablets. I walked to PRAGUE where I was recaptured five days later. /I was ....

I was sent back to Stalag VIII B where I was given 10 days' solitary confinement.

## (c) Third Attempted Escape.

After I had been back in Stalag VIII B for two months, I volunteered to go out in charge of a woodcutting party near TROPPAU-ON-ODER (Sheet 127, 9333). I escaped from here in Sep 42 with Pte. FROST, a New Zealandor. In preparation for this I dyed my uniform with indelible pencil. We walked 8 kms to the railway where we jumped on to a goods train; which was moving slowly, and hid in an empty waggon. We jumped off at daybroak and slept in some woods. We continued walking for the next two or three days, when we were captured by the police in AUSTRIA near the Austro-Czech border. We were taken to VIEWIA and then to ZLIN in CZECHOSLOVAKIA (GERMAN 1:250,000, Sheet P 50, 0 21), where we were imprisoned in a civil prison for two weeks. After that we were sent back to Stalag VIII B where we were given 21 days' solitary confinement.

## 4. ESCAPE FROM WURKING PARTY NEAR TOST.

While I was serving my sentence for my attempted escape in Sep 42 in Stalag VIII B, I met W/O. BROOKS (S/P.G.(G) 2950) who had exchanged names with an Army Private who had taken BROOKS' place in the R.A.F. compound. Together we planned another escape.

We arranged to go out on a Working Party near TOST (Sheet Q 51, Y 29) of which I was in charge and escaped from here on 10 May 43 by sawing through the bars in our but and cutting the wires round the camp. We had been saving up food for six months and had acquired a compass from a Bavarian woman. BROOKS had obtained some maps and we stole articles of clothing from the camp stores. Armed with these we set out for the Polish border. From this point TV story is the same as that of WO. BROOKS.
