THOMAS P. DUNLEAVY JR.

Thomas P. Dunleavy Jr., 42, of 2855 Tiger Tail Ave., Coconut Grove, Fla., died unexpectedly at his home after a brief illness.

He was born in Barre, Nov. 29, 1940, son of Dr. Thomas P. and Claire (Bennett) Dunleavy Sr.

He attended Lincoln School in Barre and graduated from Spaulding High School as president of the class of 1958. He had been active in school and was a varsity football player for four years.

In 1962, he received a Bachelor of Science degree in economics at the University of Notre Dame, South Bend, Ind.

From 1962 to 1964, he did graduate study at the University of Vermont.

In 1964, he joined the faculty at Villa St. Jean, a boys' preparatory school in Fribourg, Switzerland, where he taught chemistry, biology and ethics.

Mr. Dunleavy began employment in 1969 with Texaco International in West Africa and the Caribbean. He returned to the Texaco main office in Harrison, N.Y., and later in Coral Gables, Fla., as assistant manager of finance and economics in the international division. He was currently employed in that capacity.

Surviving are his parents, in Barre; two sons, T. Patrick and Christopher Dunleavy, both in Coral Gables, Fla.; four sisters, Mrs. Thomas (Ann) Gannon, Bethesda, Md.; Mrs. Richard (Martha) Pellegrini, Wilbraham, Mass.; Mrs. William (Cathy) LeClerc, Sharon, Conn., and Mary Jo Dunleavy, Watertown, Mass.; nieces and nephews.

A memorial mass will be celebrated Friday, Nov. 11, at 2 p.m. in St. Monica Church.

Committal will be in St. Monica Cemetery.

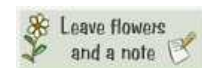
